



## Nebraska Corn Board and National Corn Growers Association Internship St. Louis, Missouri (Summer 2023)

### Position Summary

Communications and Outreach Intern in St. Louis, MO

Sponsored by the Nebraska Corn Board (NCB) and the National Corn Growers Association (NCGA)

### About

NCB manages the state's corn checkoff by investing in four key areas of market development, research, promotion and education. The mission of NCB is to promote the value of corn by creating opportunities.

NCGA is a membership organization and a federation of states that works with and for the corn states in the U.S. NCGA exists to coordinate the focus, interest and power of their dual membership into a national effort for the corn farmers in the U.S.

### Timeline

Mid-May through Mid-August 2023, for at least 10 consecutive weeks on location

### Duties & Responsibilities

Intern would be mentored and assigned responsibilities on a day-to-day basis by the NCGA staff. Students will obtain a working knowledge of the following:

- Office operations of the NCGA
- Communication efforts related to NCGA's mission of increasing opportunities for corn growers
- NCGA's strategic priorities of increasing demand; strengthening customer and consumer trust; enhancing productivity and environmental sustainability; and striving for organizational excellence
- Inter-relationships of other ag industry groups
- Opportunities to represent NCGA as assigned in meetings and reporting back to staff
- Meeting NCGA leadership and supporting their efforts
- Knowledge gained on issues affecting corn farmers

### Qualifications

Any student enrolled in a four-year university with the following qualifications:

- Agricultural background beneficial but not required
- Interest in the political process, agricultural policy, economics, agronomy, data analysis and/or communications
- Proven written and verbal communication abilities
- Excellent computer skills
- Preference will be given to students who are junior standing or above
- Preference will be given to students attending a college or university in Nebraska

### Recommended Coursework

Agricultural Policy, Agricultural Economics, International Agriculture, Marketing, Agribusiness, Political Science and Communications

### Stipend

NCB will provide a stipend which will be paid to the student through NCGA, as well as one flight to and from St. Louis, or mileage reimbursement for one trip to and from St. Louis for moving. Housing suggestions will be provided.

### Opportunity for Independent Study

Will work with the University to receive credit hours.
