WHEREAS, NCB and NeCGA have the shared vision of Enhancing Demand. Adding Value. Ensuring Sustainability; and

WHEREAS, NCB and NeCGA work collectively on the behalf of and representing corn farmers of Nebraska.

WHEREAS, NCB and NeCGA employ a joint executive director and separate staff that work collaboratively.

NOW THEREFORE, be it resolved that the NCB board of directors agree to the following points of NCB re-locating offices

1. The re-location includes the NeCGA in co-locating with NCB; and
2. The joint office maintains their independence and identity; and
3. NCB agrees to reserve space for NeCGA until time appropriate for their co-location with NCB.

MARKET DEVELOPMENT COMMITTEE

- ▶ A motion was made from the Market Development Committee to approve \$50,000 in grant funding from Ethanol Infrastructure Investment line item in the Market Development Committee budget to Frenchman Valley Farms Cooperative for its retail location in Sidney, NE. The location will offer E15, E30 and E85.

- ▶ The Market Development Committee reported to the full Board the approval of \$10,000 from Ethanol Infrastructure Investment for E15 grant funding to T-Bone Truckstop #3 in Columbus, NE.
- ▶ The Market Development Committee reported to the full Board the approval of \$10,000 from Ethanol Infrastructure Investment for E15 grant funding to Ralston Automotive in Ralston, NE.

RESEARCH COMMITTEE

- ▶ The Research Committee reported to the full Board the approval of \$5,300 to sponsor UNL 4R Nutrient Stewardship Field Day in July 2021. The field day would focus on nitrogen management in corn utilizing the 4R nutrient stewardship concept – right fertilizer source, right rate, right time, and right place – to achieve cropping system goals such as increased production, profitability, and environmental protection. The funding would come from the Research Committee Unobligated.


PUBLIC DISCUSSION
