## FISCAL YEAR 2020-21 BUDGET

The board discussed the revenue projection for FY 20/21 and agreed to set the corn fees revenue projection at \$8,444,772. This amount is based on 10.199 million acres being harvested at 180 bushels per acre. Additionally, the board added \$400,000 in additional revenue from on-farm stocks.


